

Early Childhood Education Tuition Rates & Monthly Billing

Children enrolled in Early Head Start (EHS) are billed for 48 weeks per year per program requirements, rather than the standard 50 weeks, resulting in a lower monthly bill. EHS applies only within Infant/Young Toddler and Toddler classrooms. See Parent/Guardian Handbook for more information on EHS.

Part-Time Weekly Rates

Part-time care is offered on a limited basis, as space allows. Adding an extra day to an existing part-time schedule is subject to space availability.

Drop-In Rates

Drop-in rates apply to children attending on a casual, as-needed basis with no regular weekly schedule. Arrange at least 2 weeks in advance.

K4 Wrap Care

Before & after care for the local school districts K4 programs, billed per day. "No School Days" is a drop-in rate for scheduled school closures.

Key Policies and Fees (see Parent Handbook for full policies)

- We are open Monday – Friday, 7:30 a.m. – 5:30 p.m., you will choose a 9 hour schedule.
- Late pick-up and early drop-off fees for drop-offs and pick-ups outside of the 9 hour schedule are \$10.00 per family for each 5 minutes or portion thereof outside your scheduled time.
- An extended day charge of \$10.00/day applies to pre-arranged schedules exceeding 9 hours/day; scheduling is subject to availability.
- An annual enrollment fee of \$75.00 per child is assessed upon enrollment and added to the September tuition statement thereafter.
- New enrollments are required to pay a reservation fee equal to 2 weeks' tuition, due upon acceptance of a placement offer; this fee is held as a security deposit. Enrollment paperwork must be completed and returned, and both the enrollment and reservation fees must be paid, before a child can begin attending.
- A 4-week written notice is required to withdraw; the security deposit is applied to the last 2 weeks of tuition. You will be billed for your final week based on your normal schedule. Refunds for partial weeks will not be offered.
- A 2-week notice is required to reduce a child's attendance schedule.
- Invoices are sent through LineLeader. Payment is due by 15th of the month but can be scheduled for any date between the 1st and the 15th of the month. Wisconsin Shares families' subsidy payments are due on the 5th. A 5% late payment fee applies immediately to unpaid balances and a \$35 fee applies to each returned payment.
- Sibling discount: 10% off, applied to the child with the lowest bill. The discount applies across all rate types (full-time, part-time, and drop-in) and remains in effect for families who consistently pay tuition in full.
- Financial assistance is available for families who qualify.
- Referral Rewards: refer a new family with no prior relationship with SFCC and receive a \$250 tuition credit once their child attends 8 consecutive weeks (2 credits per family per calendar year; some exclusions apply).
